

#### **ABOUT THE MEETING**

Each agenda action item and certain discussion items are supported by documents which may include written communications to members of the Airport Commission, staff reports, resolutions, and/or consultant reports. Agenda documents may be obtained by calling the Commission Secretary at 650-821-5042. The Commission Secretary has a limited number of copies at the Commission meeting. If a copy is unavailable at the meeting, the requested document(s) will be mailed, emailed, or faxed the same day.

Any materials distributed to members of the Airport Commission within 72 hours of the meeting or after the agenda packet has been delivered to the members are available for inspection at the Airport Commission Office at San Francisco International Airport, 5<sup>th</sup> Floor, International Terminal, G side during regular business hours.

Members of the public who wish to address the Commission are asked to fill out a "Request to Speak" form, located next to the speakers microphone. Please submit the form to the Commission Secretary. For items on the agenda, speakers will be called after the discussion by the Commission but before the vote. Each speaker is allowed one opportunity per calendar item to address the Commission for a period of up to two (2) minutes. For items not on the agenda, but within the Airport Commission's jurisdiction, speakers will be called under "New Business," the public comment portion of the calendar. Again, speakers will be given up to two (2) minutes.

All cell phones, pagers or other similar sound-producing devices must be turned <u>off</u> during Commission meetings; "silent mode" is prohibited as the device may interfere with the recording system. The Chair may order the removal of any person responsible for the use of a cell phone, pager, or other similar electronic device.

#### **DISABILITY ACCESS**

The Airport Commission's meeting room, Room 400, Fourth Floor, City Hall is wheelchair accessible. The closest accessible BART Station is Civic Center, three blocks from City Hall. Accessible MUNI lines serving this location are #5 Fulton, #21 Hayes, #42 Downtown Loop, #47 Van Ness and #49 City College lines and the Metro stations at Van Ness and Market and at Civic Center. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review.

#### LOBBYIST ORDINANCE

Individuals that influence or attempt to influence local policy or administrative action may be required by the San Francisco Lobbyist Ordinance (San Francisco Campaign and Government Conduct Code Sections 2.100-2.160) to register and report lobbying activity. #### CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PROCEDURES

CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code: If the Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. This appeal is separate from and in addition to an appeal of an action on a project. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Planning Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at http://www.sf-planning.org/index.aspx?page=3447. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision. ## E. ACTION ITEMS RELATING TO ADMINISTRATION, OPERATIONS & MAINTENANCE:

1. <u>Award of Professional Services Contract No. 10504.41</u> <u>Project Management Support Services for the AirTrain Extension and</u> <u>Improvements Program</u> <u>PGH Wong Engineering, Inc.</u> <u>\$4,292,000</u>

Resolution awarding Professional Services Contract No. 10504.41, Project Management Support Services for the AirTrain Extension and Improvements Program, to PGH Wong Engineering, Inc. in an amount not to exceed \$4,292,000 for the first year of services. This contract may be renewed yearly up to an estimated not to exceed amount of \$13,132,000, with a duration up to 44 months.

This item includes activities that are within the scope of the San Francisco International Airport Master Plan Program approved by the Airport Commission on November 3, 1992. The Master Plan EIR prepared for the Master Plan Program, including addenda thereto, adequately described the potential environmental effects of these activities for the purposes of the California Environmental Quality Act (CEQA). This item also includes activities addressed in greater detail in a Negative Declaration issued for the Airport Multi-Modal Transportation Center.

#### 2. <u>Award of Contract No. 50062 to Provide Communications and</u> <u>Marketing Services for Varied Scopes of Work on an As-Needed Basis</u> <u>Fuseideas/EIS Design, a Joint Venture</u> <u>\$500,000</u>

Resolution awarding Contract No. 50062 to Fuseideas/EIS Design, a Joint Venture, for a total annual not-to-exceed amount of \$500,000 to provide Communications and Marketing services for varied scopes of work for an initial period of three (3) years with two (2) two-year options to extend the contract at the sole discretion of the Commission.

Resolution awarding Professional Services Contract No. 10511.41, Project Management Support Services for Airport Security Infrastructure Program, to Faith Group, LLC, in an amount not to exceed \$2,671,000 for the first year of services. This contract may be renewed yearly up to an estimated not to exceed amount of \$6,241,000, with a duration up to 48 months.

#### 4. <u>Modification No. 6 to Contract No. 9024.9, Construction Management</u> <u>Services for the International Terminal and Boarding Area F Checked</u> <u>Baggage Inspection System Modernization Program, and the</u> <u>International Terminal Baggage Handling System Improvements Project</u> <u>CAGE Professional Services, Inc. (dba CAGE, Inc.)</u> <u>\$1,350,000</u>

Resolution approving Modification No. 6 to Contract No. 9024.9, Construction Management Services for the International Terminal and Boarding Area F Checked Baggage Inspection System Modernization Program and the International Terminal Baggage Handling System Improvements Project with CAGE Professional Services, Inc. (dba CAGE, Inc.) to increase the not-toexceed amount by \$1,350,000 for a new total contract amount not to exceed \$9,945,000 and increase the contract by 12 months for a new contract duration of 63 months.

#### 5. <u>Modification No. 1 to Contract No. 10512.66, Design-Build Services for</u> <u>the Lot D Improvements and PARCS Automation Project</u> <u>Galliera, Inc., dba Trico Construction</u> <u>\$900,000</u>

Resolution approving Modification No. 1 to Contract No. 10512.66, Design-Build Services for the Lot D Improvements and PARCS Automation Project, with Galliera, Inc., dba Trico Construction in an amount of \$900,000 for a new total contract amount not to exceed \$2,797,092 and a new contract duration of 360 consecutive calendar days.
